### **OUR CHURCH**

For centuries St Mary's Church has been home to a company of faithful people, and today we rejoice in our heritage and encourage one another to play a full part in all the different aspects of Church life.

As well as being a place where we gather to worship, St Mary's is a reminder of the presence of God in our daily lives as we walk or drive through the village. Our work in the village continues and is growing: regular worship, study groups, children's activities, the welcoming of newcomers and the pastoral care of the sick and bereaved — ministry in many areas of village life.

### **OUR VISION FOR THE FUTURE**

We have a vision for growth of our congregation, to increase our community outreach, and to preserve and beautify our Church and its surrounds. What we require is faith, boldness, and generosity in giving according to our circumstances. By God's grace and our commitment, we will have the resources to accomplish this vision. Specifically, our priorities for our parish include:

- To be an energetic and attractive Christian witness in our communities and encourage lay ministry:
- To better serve our semi-rural community;
- To have inspired worship and present the Gospel to all;
- To engage with faith in a relevant and intellectually stimulating way;
- To reach out to groups under-represented in our current congregation, especially the young.

### **HOW ARE YOUR DONATIONS USED?**

Your donations support:

- \*Our beautiful building it is a sacred place dedicated to worship, prayer and witness, and it is open daily as a place of reflection and calm. It provides a well-maintained and welcoming venue for community gatherings, celebrating the arts, and other events for everyone to enjoy.
- The maintenance of the churchyard and its lovely natural setting where generations of villagers are remembered.

- Our parish clergy both here and in the wider family of the Church. We have a full-time Christian minister available at all times to serve our community. Your giving supports training others called to lay and ordained ministry so that the life of the Church will continue on in the future.
- Parish ministry, measured by every ill person visited and every bereaved family cared and prayed for, weddings and baptisms, every Eucharist celebrated, and every special Remembrance Service at the War Memorial, Christmas Carol Service, and Easter celebration.
- Our shared ministry as people of faith, working together to show the love of God through our service, care, comfort and compassion for others in the community and world wide by organising children's workshops, coffee mornings, supporting charitable causes, and highlighting social justice, as well as building fellowship through book groups, discussion groups, and social events.

### **HOW MUCH IS NEEDED?**

Currently, our necessary expenses require approximately £2,800 per month. Sadly, donations and other income (such as from fundraisers and ministerial fees) average only £2,100 per month, leaving us with a shortfall of £700 per month.

### **GIVING TO OUR CHURCH**

Firstly, a thank you - giving and gratitude go together. We give out of gratitude for what we receive from God. Also, we continue to be grateful for those, who, even in these difficult financial times, give regularly and sacrificially to support the work of God and this Parish.

### **HOW CAN YOU HELP?**

- If you are not yet a regular giver to the Church, please pray about whether you could consider regular, planned giving.
- If you are an existing regular giver, please consider increasing your gift.
- If possible, please make your gift by Standing Order by completing the form and returning it to your bank. You can also give regularly by envelopes.

Take advantage of Gift Aid by signing the declaration form and returning it to our Treasurer. This means that for every £1.00 you give to the Church, the Church can reclaim an additional 25p from HMRC, increasing the value of your donation to £1.25 for every pound you give.

### **HOW MUCH SHOULD ONE GIVE?**

"Each of you must give as you have made up your mind, not reluctantly or under compulsion, for God loves a cheerful giver. And God is able to provide you with every blessing in abundance, so that by always having enough of everything, you may share abundantly in every good work."

(2 Corinthians. 9: 7-8)



What is a modest gift from one may be truly sacrificial from another. The Church recognises that these are difficult financial times for many, just as it is a difficult time financially for the Church itself.

The Church of England's guidance encourages Christians to give 5% (or £1 in £20) of their after-tax income to and through the Church, and a similar amount to other work that helps to build God's kingdom. This is consistent with the biblical principle of the tithe. If everyone associated with St. Mary's Church gave at this level, the Church would have less difficulty meeting its financial commitments.

We hope you will prayerfully consider how you can participate in helping to resource St. Mary's vision for the future.
